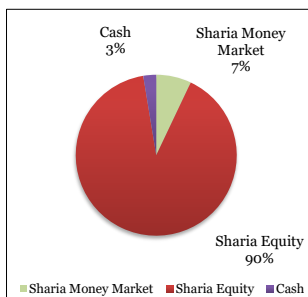
### Investment Manager Profile

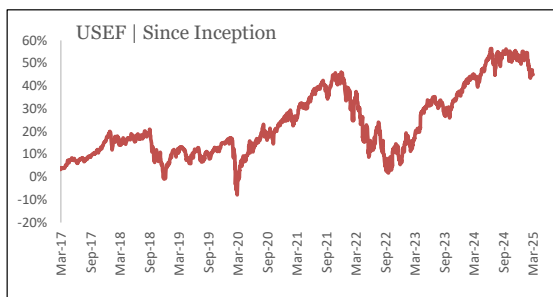
### Investment Objective
