Privacy Policy

Chubb Insurance Company of Puerto Rico appreciates having you as one of our customers. That is why we want to tell you about our Privacy Policy.

The following discloses our Practices for handling your non-public personal financial information (hereinafter "Personal Information") always safeguarding and protecting the information you share with us. This Privacy Policy includes examples of the types of personal information we collect and companies with whom we share that information. These examples are illustrative and should not be considered as a complete inventory of our collection, use and disclosure of information. We also provide an opportunity to prevent share your personal information with companies that are not our affiliates.

1. How we collect information

We collect information:

- you have provided on applications and other forms or documents as your name, address, social security number, income and beneficiaries.
- coming from transactions you make with us and with our affiliates, such as your policy cover, premiums and payment history;
- consumer credit agencies provide us such as your creditworthiness and credit history;
- customers or suppliers provide us to offer them our insurance products.

2. Information We Share

Occasionally, we may share the information described above, as permitted by law, to the following persons:

- affiliates engaged in the sale of property insurance, contingency, accident and health.
- financial providers, such as general agents and insurance agencies services.
- non-financial companies, such that ones who provide service of sending documents by mail
- marketing companies that provide us direct marketing and telemarketing services to offer our products.

3. Policy about information of previous customers

Chubb Insurance Company of Puerto Rico may share information about their previous clients just as it does with their current customers. The information about previous customers is retained for the time required by federal and local laws and regulations that govern the insurance industry.

4. Security Measures:

In addition, we maintain physical and electronic measures to safeguard the confidentiality of your information as required by law and our Privacy Policy.
