Community College

Chubb Risk Engineering Services partnered with a Community College to enhance their safety and risk management strategies through innovative technology. By integrating Unmanned Aerial Systems (UAS), commonly known as drones, into their inspection processes, Chubb provided a comprehensive and safer assessment of the college's facilities. Multiple drone flights were conducted, capturing high-resolution visual and infrared thermography images of the building's roofs. This advanced approach identified potential issues such as water intrusion, debris, ponding, and vegetation that could lead to future damage if not addressed. The detailed imagery and data collected allowed for a thorough evaluation without the need for risky physical inspections, ensuring a safer environment for both employees and the college. The Community College Foundation received actionable insights to mitigate potential losses and maintain the integrity of their infrastructure, exemplifying the successful integration of cutting-edge technology in risk management.

Municipal Pool

To determine if the pool's exposures were within Chubb's appetite, Chubb's underwriters capitalized on the expertise of their risk consulting team and arranged for several surveys.
