Directors & Officers (D&O) and Entity Liability Insurance for claims alleging mismanagement involving financials, negligent acts, regulatory compliance issues, and more.

To reduce costs, a medical practice terminated several physicians. Two of these physicians subsequently sued the practice for damages claiming deceptive trade practices, tortious interference with existing business and patient relationships, negligent misrepresentation related to their shareholder agreement, and misappropriation and conversion of lost profits.
Total loss exceeded \$450,000.



Employment Practices Liability (EPL) Insurance for claims alleging harassment, discrimination, wrongful termination, retaliation, defamation, and more.

A registered nurse was terminated for falsifying a patient's medical record. She filed a Charge of Discrimination and later a lawsuit, claiming her termination was retaliatory for requesting a disability accommodation from her employer.
Total loss exceeded \$200,000.



Fiduciary Liability Insurance for claims arising from management and administration of employee benefits.

After an employee's child fell ill and incurred medical expenses, the medical insurance provider denied the claim because the child was not covered under the plan. The employee subsequently sued his employer for failing to submit the enrollment forms promptly.
Total loss exceeded \$200,000.



Crime Insurance for losses from theft, fraudulent electronic funds transfer, forgery, and social engineering schemes by employees and third parties.

During his employment, an employee created a fictitious firm that allegedly provided financial services to the organization. The loss was not discovered until after the employee had left the organization, at which time he admitted that he had established the phantom firm for the sole purpose of stealing from his employer.
Total loss exceeded \$600,000.
