Claims scenarios



Nursing error leads to 'failure to warn' allegation against catheter manufacturer

A dialysis patient lost consciousness and became unresponsive during treatment due to a nurse's error in improperly placing a catheter. The patient developed a central air embolus and anoxic encephalopathy. The nurse's insurer paid the maximum liability of \$250,000. The rest of the settlement was attributed to the catheter manufacturer for "failure to warn."

Potential Cost: USD 1.2M



Patient injured from ingesting product after its withdrawal from market

Contamination in a batch of cold medication led a manufacturer of over-the-counter products to issue a Class 1 recall of the medication. Unfortunately, not all consumers were aware of the recall. Three months later, a woman suffered an adverse reaction after taking the medication for the first time.

Potential Cost: USD 1M



Software glitch invalidates clinical trial data

A contract research organisation (CRO) was contracted to provide clinical trial services in Europe. An error in the CRO's software program failed to properly randomise participants in one of the trials. As a result, the trial deviated from its intended design, rendering the data unusable and costing their customer millions of dollars to re-do the trial.

Potential Cost: USD 8.2M



Product contaminated by raw material

Contaminated raw material was incorporated into a pharmaceutical company's product during manufacturing. This went unnoticed until several batches had been produced, affecting a large volume of finished product. Although only 10% of finished stock was directly contaminated, the FDA condemned all product batches.

Potential Cost: USD 450,000
